## DEALINGS DISCLOSURE LEVEL OF ACCEPTANCES OF OFFER

### 1. INTRODUCTION

United Overseas Bank Limited ("UOB") refers to:

- (a) the announcement dated 14 November 2023 (the "Offer Announcement") issued by UOB, for and on behalf of Amethyst Assets Pte. Ltd. (the "Offeror"), in connection with the voluntary unconditional cash offer (the "Offer") for all the issued and paid-up ordinary shares (the "Shares") in the capital of Amara Holdings Limited (the "Company"), other than Shares held in treasury and Shares held, directly or indirectly, by the Offeror as at the date of the Offer;
- (b) the offer document dated 5 December 2023 (the "Offer Document") issued by UOB, for and on behalf of the Offeror, in connection with the Offer; and
- (c) the announcement dated 2 January 2024 issued by UOB, for and on behalf of the Offeror, in relation to, *inter alia*, the extension of the Closing Date.

All capitalised terms used but not defined herein shall have the same meanings given to them in the Offer Document, unless otherwise expressly stated or the context otherwise requires.

## 2. DEALINGS IN SHARES

Pursuant to Rule 12.1 of the Code, UOB wishes to announce, for and on behalf of the Offeror, the following dealings in Shares by the Offeror on 8 January 2024:

(a)	Total number of Shares acquired	40,000
(b)	Percentage of issued share capital of the Company constituted by the total number of Shares acquired	0.01% <sup>1</sup>
(c)	Price paid per Share (excluding brokerage commission, clearing fees, stamp duties and Goods and Services Tax)	S\$0.60

## 3. LEVEL OF ACCEPTANCES

UOB wishes to announce, for and on behalf of the Offeror, that:

- (a) **Acceptances of the Offer.** As at 6.00 p.m. (Singapore time) on 8 January 2024, based on information available to the Offeror, the Offeror has received valid acceptances amounting to 416,572,541 Shares, representing approximately 72.45% of the total number of Shares. This includes acceptances received from persons acting or deemed to be acting in concert with the Offeror in respect of an aggregate of 351,239,510 Shares, representing approximately 61.09% of the total number of Shares<sup>2</sup>.
- (b) **Shares held as at the Holding Announcement Date.** As at the Holding Announcement Date:
- (i) the Offeror did not hold any Shares; and
  - (ii) the persons acting or deemed to be acting in concert with the Offeror collectively owned or controlled an aggregate of 421,281,500 Shares, representing approximately 73.27% of the total number of Shares.
- (c) **Shares acquired or agreed to be acquired after the Holding Announcement Date and up to 6.00 p.m. (Singapore time) on 8 January 2024 (other than pursuant to**

**valid acceptances of the Offer).** Following the Holding Announcement Date and up to 6.00 p.m. (Singapore time) on 8 January 2024, save for the acquisitions by (i) Teo Kheng Chuan on the SGX-ST of an aggregate of 80,000 Shares, representing approximately 0.01% of the total number of Shares; and (ii) the Offeror on the SGX-ST of an aggregate of 19,532,700 Shares, representing approximately 3.40% of the total number of Shares, the Offeror and persons acting in concert with it have not acquired or agreed to acquire any Shares (other than pursuant to valid acceptances of the Offer).

#### **4. RESULTANT SHAREHOLDING**

Accordingly, as at 6.00 p.m. (Singapore time) on 8 January 2024, the total number of (a) Shares owned, controlled or agreed to be acquired by the Offeror and persons acting or deemed to be acting in concert with it; and (b) valid acceptances of the Offer, amount to an aggregate of 506,207,231 Shares, representing approximately 88.04% of the total number of Shares.

#### **5. DIRECTORS' RESPONSIBILITY STATEMENT**
