1. INTRODUCTION

United Overseas Bank Limited ("**UOB**") refers to the announcement dated 14 November 2023 (the "**Offer Announcement**") issued by UOB, for and on behalf of Amethyst Assets Pte. Ltd. (the "**Offeror**"), in connection with the voluntary unconditional cash offer (the "**Offer**") for all the issued and paid-up ordinary shares (the "**Shares**") in the capital of Amara Holdings Limited (the "**Company**"), other than Shares held in treasury and Shares held, directly or indirectly, by the Offeror as at the date of the Offer.

All capitalised terms used but not defined herein shall have the same meanings given to them in the Offer Announcement, unless otherwise expressly stated or the context otherwise requires.
